CERTIFICATE AND NOTICE OF HIGHWAY RESTRICTION

STATE OF NEW YORK:
COUNTY OF ERIE: }SS

This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby restrict that portion of the highway in the Town of Lancaster, said County, known as Erie, and described as follows:

LANE RESTRICTION:

That portion of William Street (CR 338) between Transit Road and Penora Street will have lane restrictions for paving and striping. The lane restriction will begin Monday, April 24th at 7:00 AM and end Friday, April 28th, 2017 or until completed. This is a department of Sewer Management project, and Concrete Applied Technologies Corp. is the contractor. Daytime restriction will be controlled by flag-persons.

This restriction is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
